**RELEASE OF LIABILITY FORM**

I, the undersigned, .....  
release the service provider from any liability about what might occur to me or my belongings during the

I waive my rights to any claims or actions, of whatever kind or nature, against the service provider and the  
other participants. This applies particularly in the event of accidents of any kind, injuries, thefts, damage to  
my personal belongings or anything else that might happen during the outing I am attending as scheduled  
above.

I acknowledge that I have read the terms and conditions inherent to the participation to the activities as  
offered by the service provider (hiking, swimming, etc. ... this is a non-exhaustive list).

I am also well aware that it is my responsibility to take out a compulsory health/accident and liability  
insurance.

I hereby certify being over the age of legal majority, having no medical contraindication to the practice of  
off-road motorsport and outdoor activities of any sort, and not being under the influence of alcohol or drugs  
during the outing.

Should I refuse to sign or present this form, the service provider may reserve the right to reject my  
participation to the outing.

***Liability, damage and various modalities***

***Liability***

*All participants are reminded of the risks entailed by that their presence and/or the activities taking place on  
the site of the event. By their presence, they accept to participate, being fully aware of the risks and under  
their full responsibility, with no possibility of recourse against the service provider.*

***Personal injuries***

*All participants are personally responsible for the damage they may directly or indirectly cause to the  
service provider or to any outside party.*

***Property damage***

*All participants are personally responsible for the damage they may directly or indirectly cause: for all the  
degradations, incidents and accidents that could occur on the site of the event or in the area surrounding it.  
In the event of the degradation of the infrastructures, the fauna and the flora (this is a non-exhaustive list),  
the client is responsible for repair costs or compensations.*

### **Modification/Cancellation of the outing**

*The service provider is not responsible for any delays of departures and returns, or any changes of itinerary caused by bad weather conditions that would make the track impracticable. Nor is he responsible for postponing or changing the service in case of force majeure (meteorological, etc. ...). If the service provider is forced to cancel the outing, in case of force majeure, (cyclone, etc. ...), the client will be refunded up to 80% (when the decision to cancel is made under 24 hours prior to the outing). If the decision is made over 24 hours prior, the client will be refunded in full.*

*Please note that preference will always be given to postponing the outing rather than cancelling it.*

*If the client cancels his participation less than 24 hours prior to the outing, he will be refunded up to 80% of the applied rate. If he does so more than 24 hours prior, he will be refunded in full.*

### **Transportation/Routing**

*Transportation and/or routing of participants to the site of the event is the responsibility of the client. It is not at all included in the initial rate. However, this could easily be arranged through an external service provider, either for free, or as an extra charge.*

### **Loss of documents/objects**

*The service provider is not responsible for the loss of documents, cash, or other valuables, unless he had agreed to carry them and thus had been entrusted to keep hold of them; nor is he responsible for the loss of hand luggage or other personal belongings.*

### **Meals**

*Alcohol, medicine and drug consumption of any kind is strictly prohibited for the duration of the outing. All meals are usually included in the rate. The service provider denies any liability with regard to allergies, especially if the participants failed to mention them beforehand. However, the participants may prepare and bring their own meals, which can be stored and transported in refrigerators, free of charge.*

### **Safety**

*Drinking, eating and the use of recording devices are prohibited in case the service provider is driving on off-road tracks. All participants must take all the necessary measures to hold on to the vehicle tightly for the duration of the transport, if said drive actually takes place.*
